CONFERENCE VENUE

CONFERENCE HALL

BILATERAL AGREEMENT

BETWEEN

UNIVERSITY OF "UKSHIN HOTI" PRIZREN

AND

NAMIK KEMAL UNIVERSITY

Prof. Dr. Rame Vataj, the Rector of University of "Ukshin Hoti" Prizren, Republic of Kosova, Prishtina and Prof. Dr. Osman Şimşek, the Rector of Namık Kemal University, Tekirdağ, Turkey, with the objective of promoting cooperation in the fields of education and academic research, agree to conclude the following agreement on academic exchange.

Article 1

Both parties agree to promote the following activities so as to enhance their educational and academic research in the necessary fields:

- (1) Activities such as collaborative research, lectures, symposiums, etc., and the exchange of researchers pertaining thereto;
- (2) Development of mutually beneficial academic programmes and courses;
- (3) Exchange of information and materials in those fields, which are of interest to both parties;
- (4) Exchange of undergraduate and graduate students (not more than 2 students per academic year);
- (5) Possible publications of scientific papers.

Article 2

Specific matters pertaining to the implementation of the exchanges based on this agreement shall be negotiated and agreed upon between both parties considered in each specific case and may be stipulated in writing as memorandums complementary to this agreement.

Article 3

This agreement shall become effective on the date of its signing by the representatives of both parties and shall be in force for five years.

Article 4

This agreement is subject to revisions by mutual written consent.

Article 5

Either party may, by giving six months' written notice to the other party, terminate the agreement. However, the termination of this agreement shall not affect the implementation of the collaborative activities established under it prior to such termination.

Article 6

In the absence of any such early termination, the renewal of this agreement shall be discussed by the two parties not less than 6 months prior to the natural termination of the current agreement.

Article 7

This agreement is to be executed in English and each university shall retain a copy.
