## **COOPERATION AGREEMENT**

*BETWEEN*

**“UKSHIN HOTI” UNIVERSITY PRIZREN**

*AND*

**PRIZRENI MUNICIPALITY**

**FOR**

**EXCHANGE OF EXPERIENCES**

### Article 1

The Cooperation Agreement (hereinafter referred to as the Agreement) is concluded between the Municipality of Prizren, represented by the Mayor Prof. Dr. Mytaher Haskuka and "Ukshin HOTI" University of Prizren, represented by Rector Assoc. Dr. Ismet Temaj.

### Article 2

The purpose of this Cooperation Agreement is to set out the terms of cooperation between the two institutions for mutual interest.

### Article 3

The Municipality of Prizren and the University "Ukshin HOTI" of Prizren agree that it is in their common interest to assist, promote, support and raise the level of mutual cooperation between them, in view of overall educational, social and economic development and professional development of students of UPZ.

### Article 4

The Municipality of Prizren and the University "Ukshin HOTI" of Prizren will jointly contribute to the development, support and promotion of the educational and vocational sector, the provision of relevant services for this university, the generation of employment and the reduction of unemployment. In this regard, the University of Prizren will provide scientific-professional assistance to the Municipality of Prizren with its services.

### Article 5

Municipality of Prizren and University "Ukshin HOTI" of Prizren agree that in preparing proposals and realizing joint projects related to improving the economic and social environment in Prizren, compilation of economic analysis, shall regularly submit a presentation sharing necessary information for project implementation.

#### Article 6

The Municipality of Prizren will receive on a monthly basis a number of students from "Ukshin HOTI" University of Prizren to do professional internships in the offices of the Municipality and subordinate institutions.

#### Article 7

Municipality of Prizren will commit to provide scholarships to the most prominent students of UPZ and economically disadvantaged, including families of martyrs.

#### Article 8

The Municipality of Prizren and the "Ukshin HOTI" University agree that for their needs they shall exchange experts and their experiences in certain areas that have the capacity of both parties.

#### Article 9

Prizren Municipality and Ukshin HOTI University agree to engage a family medicine doctor and a nurse on the UPZ Campus.

#### Article 10

Municipality of Prizren and "Ukshin HOTI" University agree on the use of municipal institutions and spaces for students, such as: Municipal Library, Sports Center "Sezai Surroi", sports fields, municipal cultural institutions, etc.;

#### Article 11

Municipality of Prizren and "Ukshin HOTI" University agree to cooperate during the process of drafting strategic plans and documents of both parties.

#### Article 12

The Municipality of Prizren agrees to plan the allocation of communal spaces and land for the needs of UPZ infrastructure expansion and for the specific needs of the respective faculties, in accordance with applicable laws.

#### Article 13

The Agreement has a validity period of 5 (five) years of cooperation with the possibility of extension, supplementation or amendment with the consent of both parties.

#### Article 14

The cooperation agreement is signed in two copies in Albanian and two copies in English. In case of any discrepancies, the copy in Albanian language shall prevail.

#### Article 15

This Agreement shall enter into force on the day it is signed by the signatory parties.
