


# MEMORANDUM OF UNDERSTANDING (MOU)

BETWEEN

## Article 1

The Memorandum of Understanding (hereinafter referred to as the MoU) is concluded between the Project Implementation Unit of Innovation and Training Park (ITP) Prizren of Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH (hereinafter referred to as the ITP project), represented by Mr. Wolfgang Leidig, and the University "Ukshin Hoti" Prizren (hereinafter referred to as the University), represented by the Rector, Prof. Asoc. Dr. Ismet Temaj.

## Article 2

The purpose of this MoU is to determine the terms of cooperation between the two institutions for mutual interest.

## Article 3

The ITP project and the University agree that it is in the common interest to assist, promote and enhance the level of mutual cooperation between them, with the purpose to support the overall educational, social and economic development of Kosovo and the professional development of the University students of Prizren.

## Article 4

The ITP project and the University will jointly engage in the development and promotion of the educational and vocational sector, the promotion of investments in the ITP as well as relevant University services, thereby contributing to the generation of employment opportunities and the improvement of the economic and social environment in Kosovo and the region. In this regard, the University of Prizren will strive to provide the ITP project with research and teaching assistance and services.

## Article 5

The ITP project will accept a number of University students to complete professional practice, subject to the availability of training places in the park and will promote the same among tenant businesses and organizations in the park.

## Article 6

The ITP project expresses its readiness to offer infrastructure facilities for University faculties, living spaces (dormitories) and the use of the canteen for University students and summer school students, all of which would be specified in separate agreements.

## Article 7

The ITP project and the University agree to exchange experts and their experience in specific fields, subject to the capacities of both parties.

## Article 8

The ITP project and the University agree to establish a working group to implement the collaboration with the different University faculties, in particular with the Faculty of Economics,

the Faculty of Life and Environmental Sciences and the Faculty of Computer Sciences, as well as the International Summer School and Career Fair.

#### Article 9

The ITP project and the University agree to exchange information and to cooperate in the preparation of project proposals as well as in the implementation of joint projects. The University will be available to the ITP project with advisory services and expertise for businesses, industries, institutions and community organizations that will be located at the park.

#### Article 10

The ITP project and the University agree to offer each other the use of the other party's spaces, the manner of use of which shall be specified in a separate agreement, whenever the need arises.

#### Article 11

The ITP project and the University will offer each other assistance in the process of drafting strategic plans and documents.

#### Article 12

Nothing in this MoU shall be understood or construed as a binding right or obligation of the parties or as obligating the undersigning parties hereto to finally conclude any agreement. In particular, this MoU in no way restricts either party from pursuing similar activities on its own or from participating in similar activities with other public or private agencies, organizations, and individuals and shall not provide exclusivity between the parties in the scope of any cooperation, does not endorse a specific entity, does not create any rights for any person, and does not create any obligations for any third party.

#### Article 13

This MoU is signed in two copies in English language and shall become effective on the day of signature and remain in force until 30 April 2022.

An extension of this MoU may be possible and would require an additional annex. The parties may terminate this MoU at any time with 6 weeks prior written notice.
