



MEMORANDUM OF UNDERSTANDING BETWEEN TRAKYA UNIVERSITY, REPUBLIC OF TURKEY AND UNIVERSITY OF PRIZREN, KOSOVO

THIS AGREEMENT is made and entered into this 6th day of December, 2046, by the Trakya University hereinafter referred to as "TU", Republic of Turkey and University of Prizren, hereinafter referred to as "UPZ" Kosovo.

The two institutions wish to expand scholarly ties and promote closer academic collaboration and therefore agree as follows:

- 1. Both institutions are united by common interests and objectives in educational exchange, and they wish to maintain and promote channels of communication that permit those mutual exchanges.
- 2. This agreement will govern the general framework of academic exchanges between TU and UPZ. Individual working agreements, should they arise, will be executed for specific projects under this Agreement.
- 3. The individual working agreement(s) referred to in paragraph 2 may be developed for, but need not be limited to, the exchange of faculty and students.
- 4. Each institution will be responsible for the travel coasts of its own faculty or officials involved in mutual exchange activities under this agreement.
- 5. Each institution will take action to make the substance of this Memorandum of Understanding known to its appropriate personnel, and will provide normal and reasonable assistance such personnel in regard to the administrative details of exchanges and work agreements.
- 6. Each institution will appoint a liaison. The liaison will, together, be responsible for tracking cooperative efforts, facilitating mutual assistance, and making an annual report to the both institutions of the previous year's joint activities and initiatives in progress for the next year.
- 7. This Memorandum of Understanding may be modified or extended by written consent of both parties as provided by its officially authorized representatives.
- 8. This Memorandum of Understanding will become effective on date above and remain effective for five years from that date. It may be renewed for additional term of five years

- by an exchange of letters between the Rector of Trakya University and the Rector of University of Prizren.
- 9. This Agreement does not oblige either UPZ or TU to take any financial expenditure or other contractual obligations.
- 10. The assignment of this agreement to any other party or parties is expressly prohibited except with the written concurrence by the appropriate authorities of both TU and UPZ.
- 11. The English version of this agreement shall be authoritative version of the agreement for all purposes. In the event of a conflict between the English version and any translation of this agreement, the English version shall control.
- 12. This agreement constitutes the entire agreement of the parties: and any future agreement, understanding, or a waiver, to be binding upon the parties must be reduced to writing signed by the parties
